

**BOROUGH OF FLORHAM PARK
ORDINANCE # 11-5**

**AN ORDINANCE AMENDING CHAPTER 216 OF THE REVISED GENERAL
ORDINANCES OF THE BOROUGH OF FLORHAM PARK TO REVISE
REGISTRATION FEES FOR THE FLORHAM PARK MUNICIPAL POOL**

WHEREAS, the costs of operating and maintaining the Florham Park Municipal Pool have increased significantly, with the need for repair and maintenance of the pool becoming an imminent need; and

WHEREAS, the Mayor and Borough Council have deemed it necessary to adjust the costs of the registration fees for the Municipal Pool to cover these increased costs;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Florham Park, in the County of Morris and State of New Jersey, as follows:

Section 1. Section 216-32, entitled Registration Fees, of Chapter 216 of the Revised General Ordinances of the Borough of Florham Park entitled “Swimming Pools,” shall be amended and revised to read in its entirety as follows:

§ 216-32. Registration fees.

Section 2. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or

provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 3. All Ordinances, or parts of Ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 4. This Ordinance shall take effect immediately after final passage in the manner provided by law.
