



**BOROUGH OF FLORHAM PARK
ORDINANCE #15-13**

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF FLORHAM PARK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY TO DESIGNATE THE BOROUGH ADMINISTRATOR AS THE “APPROPRIATE AUTHORITY” WITH RESPECT TO POLICE DEPARTMENT POLICIES AND PROCEDURES

WHEREAS; N.J.S.A. 40:14-118 requires that an “appropriate authority” be designated by Ordinance with respect to certain policies and procedures of the Police Department; and

WHEREAS, the Borough Council has reviewed the existing Ordinance and determined that the “appropriate authority” should now be designated as the Borough Administrator.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Florham Park, County of Morris, State of New Jersey, as follows:

SECTION 1 – Chapter 46: Police Department, Section 46-3 entitled “Appropriate Authority; Rules and Regulations” of the Code of the Borough of Florham Park, is hereby amended to read in its entirety as follows:

The Borough Administrator shall be designated as the "appropriate authority" as provided in the New Jersey Statutes who shall be responsible for the overall performance of the Police Department. The Mayor and Council, by resolution, shall adopt and promulgate rules and regulations for the government of the Police Department and for the discipline of its members, which shall be enforced by the “appropriate authority”.

SECTION 2 – All ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION 3 - If any article, section, subsection, paragraph, phrase or sentence of this ordinance is for any reason declared to be invalid, such declaration shall not affect the remainder of the ordinance.

SECTION 4 - This ordinance shall take effect upon final publication as provided for by law.
