**AN ORDINANCE OF THE GOVERNING BODY OF THE
BOROUGH OF FLORHAM PARK IN THE COUNTY OF
MORRIS, STATE OF NEW JERSEY, AMENDING AND
SUPPLEMENTING ORDINANCE 15-8 ENTITLED AN
ORDINANCE ESTABLISHING SALARIES AND WAGES
FOR NON-UNION EMPLOYEES OF THE BOROUGH OF
FLORHAM PARK FOR 2015, SCHEDULE (D)
COMPENSATION FOR SEASONAL, HOURLY,
TEMPORARY AND PART-TIME EMPLOYEES**

WHEREAS, the Mayor and Borough Council of the Borough of Florham Park wish to revise Schedule (D) of Ordinance 15-8 entitled “An Ordinance Establishing Salaries and Wages for Non-Union Employees of the Borough of Florham Park 2015” for the position of Fire Official.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Florham Park, County of Morris, New Jersey, as follows:

SECTION 1. Amending and Supplementing Schedule (D) of Ordinance 15-8 entitled “An Ordinance Establishing Salaries and Wages for Non-Union Employees of the Borough of Florham Park 2015” as to the position of Fire Official to now read as follows:

Position Title	Maximum Annual Salary
Fire Official	\$13,500

SECTION 2. All ordinances of the Borough of Florham Park which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. If any provision of this ordinance is declared to be invalid by a court of competent jurisdiction, this declaration shall not affect the remainder of the ordinance.

SECTION 4. This ordinance shall take effect upon final passage and publication as provided by law.
