



**BOROUGH OF FLORHAM PARK  
ORDINANCE #16-15**

**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE  
BOROUGH OF FLORHAM PARK, IN THE COUNTY OF MORRIS, STATE OF NEW  
JERSEY, AMENDING AND SUPPLEMENTING SECTION 24 OF CHAPTER 238 OF  
THE BOROUGH CODE, ENTITLED “VEHICLES AND TRAFFIC - STOP  
INTERSECTIONS”**

**BE IT ORDAINED**, by the Mayor and Borough Council of the Borough of Florham Park, in the County of Morris, State of New Jersey and pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. Stop signs shall be installed as provided herein.

**WHEREAS**, the Municipal Engineer and Chief of Police of the Borough of Florham Park have recommended that the following intersections be designated as Stop Intersections in the interest of public safety; and

**WHEREAS**, the Borough Engineer, as Engineer of record, has certified the stop sign(s) locations;

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Florham Park in the County of Morris, State of New Jersey New Jersey, that the following intersections be hereby designated as Stop Intersections.

**Section 1 -**

**Intersection:**

Rosemont Hills Drive & Heritage Road

Driftway & Summit Road

**Stop Sign(s) on:**

Rosemont Hills Drive

Driftway

Driftway & Summit Road	Summit Road southbound only
Old Mill Road & Kenwood Lane	Kenwood Lane
Old Mill Road & Townsend Drive	Old Mill Road (both ends)
Townsend Drive & Kenwood Lane	Kenwood Lane
Townsend Drive & Hancock Drive	Hancock Drive
Corey Road & Hopping Lane	Hopping Lane (both legs)
Corey Road & Shetland Road	Corey Road

**Section 2 -**

The effectiveness of this Ordinance is contingent on signs being erected as required by law.

**Section 3 –**

Unless another penalty is expressly provided by New Jersey Statute, every person convicted of a violating a provision of this ordinance or any supplement thereto shall be liable to a penalty of not more than fifty dollars (\$50.00) or imprisonment for a term not exceeding fifteen (15) days or both.

**Section 4 –**

All ordinances or parts of ordinances inconsistent with the provisions of this ordinance shall be repealed to the extent of such inconsistency only.

**Section 5 –**

Should any section, paragraph, clause or any other portion of this ordinance be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this ordinance.

**Section 6 –**

This ordinance shall take effect upon final passage and publication according to law.
